# SUPERINTENDENT'S REPORT

Mr. Kelly Ricklic, Buildings and Grounds, reported on the summer paving/lighting project. It is scheduled to begin May 27 and be completed on August 1, 2015. The contractors will provide a schedule for the work that Mr. Ricklic will provide to the Board. He also told the Board that Hipkins will be starting back on the wall project soon. He also said that the sculpture project should be completed by mid-May. He is completing the cleaning schedule for this summer. They are preparing the equipment now that will be needed for the summer. Mr. Ricklic also reported that the basement floor has been poured at the house. They are working on the shingles. The industrial electricity class is working on the rough wiring. The goals is to have the outside of the house and the lawn completed at the end of the school year. Mr. Bob Alsept, Superintendent, gave an enrollment update. He told the Board that there are currently 469 new applications for next school year, as of April 10, 2015. That is before the Open House that was held on April 16. The goal is over 500. He also reported on the Career Connections event that was held on April 17. He said that there were 17 speakers, with 50 employers participating. He said that the students were very well prepared. He said that the staff had done a great job of coaching their students. He also told the Board that many of the students handed out resumes and business cards. He said that the surveys that were completed by the employers were very positive. Mr. Alsept also thanked Phyllis Willison, Cafeteria Manager, for all of the events that she and her staff had done over the last few days. There were over 400 meals served at the Open House. Mr. Bowdish said that his wife, Robin, had recently had a training at Buckeye and she was very pleased with the facilities. Mr. Wes Hostetler, said that he had attended the Career Connections on Friday, and that the staff had done an excellent job. Mr. Alsept told the Board that the Chamber of Commerce would be holding their breakfast on Friday at Buckeye.
