Megan Zimmerman, Adult Education Student Service Coordinator, reminded the Board that they will be receiving new accreditation. Mr. Alsept, Superintendent, shared information about the changes to graduation requirements that take effect for the Class of 2018. Students have to meet one of three criteria, and one of those is to earn a State Board of Education-approved, industry recognized credential or state-issued license for practice in a career and achieve a score that demonstrates workforce readiness and employability on a job skills assessment.
